- a) Open Space committee: Pete Bonnano...Dock should be removed in winter, Pete will have the installer come and remove for a small fee. He would like to see the T put on the end of the dock in the next year or two when funds allow to stabilize doc. Also, paths were cleared this year. Items needed to be done in future with help of work crew: orange paint renewed along path, picnic tables stained.
- b) Entry Way Report: Doug Kurras...Homes supplying lighting for entry way cannot continue, looking into solar lighting currently. Seasonal plantings will be done by landscaper at both entrances, and they will be doing some discretionary trimming of the town property along the roads that have become overgrown.
- c) Pond issues: Doug Kurras...Handout to be posted on website by Doug regarding budgeted amount for ponds weed cleanup. The board will purchase a CD on behalf of the HOA in the amount of \$12,000 in January representing accrued funds for future dam spillway repairs. The CD will be renewed annually and increased in amount as approved by HOA majority vote until spillway project moves forward. Any redirection of funds would require a majority vote by the HOA.
